Upon routine inspection, an uncontrolled cross-connection was discovered between a non-potable line and the potable water distribution system, posing a potential risk of contamination to the drinking water supply; immediate corrective measures were taken, including isolating the connection, conducting a thorough system assessment to identify the full extent of the cross-connection, and installing appropriate backflow prevention devices, after which the system was flushed, retested, and verified to be in compliance with applicable Colorado drinking water regulations and CDPHE requirements.
